POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 12 MAY 2026

At the Annual General Meeting of Galaxy Entertainment Group Limited (“GEG”) held on 12 May 2026 (“AGM”), a poll was demanded by the chairman of the meeting for voting on all resolutions as set out in the Notice of AGM dated 10 April 2026.

As at the date of the AGM, the total number of issued shares of GEG was 4,379,240,712 shares, which was the total number of shares entitling the shareholders to attend and vote on all resolutions. There were no restrictions on any shareholders to cast votes on any of the proposed resolutions at the AGM.

GEG’s share registrar, Computershare Hong Kong Investor Services Limited, acted as the scrutineers for the purpose of vote-taking at the AGM. All resolutions put to the meeting were approved by shareholders of GEG.

All directors of GEG except Mr. Michael Victor Mecca attended the AGM in person.
